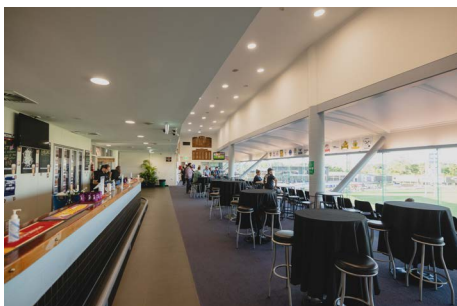

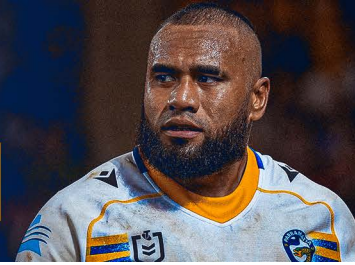

TERMS AND CONDITIONS

HOSPITALITY BOOKING TERMS AND CONDITIONS

1. Bookings (each a “**Booking**”) for the following event hospitality must be made by completing and submitting the booking form to Northern Territory Major Events Company (NTMEC) (ABN 22 085 961 520)
2. By submitting the booking form, you warrant that you are authorised to make the Booking on behalf of the party set out in the relevant booking form.
3. Bookings will be confirmed once the booking form has been returned and the appropriate deposit paid.
 - Any Bookings valued less than \$5,000 will be subject to 100% payment made within 7 days.
4. A non-refundable deposit of 20% of the purchase price for all Bookings (the “**Deposit**”) must be paid within five (5) business days of submitting the booking form. Tickets will only be issued upon full payment. Full payment must be made to NTMEC no later than 60 days prior to the Event. If full payment is not received by this time NTMEC may, at its complete discretion, cancel the Booking and retain the Deposit already paid.
 - Bookings may only be cancelled in writing to NTMEC
 - Cancellations on or before the date which is 60 days prior to the relevant Event, NTMEC will retain the Deposit.
 - Cancellations 60 days prior but before the date which is 30 days prior, you will be liable to pay 75% of the Booking.
 - Cancellations on or 30 days prior to the Event, you will be liable to pay 100% of the Booking.
5. If payments are made by direct bank transfer, an invoice number or the contracting parties’ full name as set out on the Booking must be quoted in the bank transfer reference.
6. Tickets cannot be used for promotional purposes or on sold by or to a third party without the prior written consent of NTMEC.
7. Tickets cannot be used by more than one person per day.
8. To the maximum extent permitted by law, NTMEC and its related body corporate (including officers, employees and agents) shall not be liable for any loss, damage, expenses or injury (including but not limited to indirect, special, incidental, exemplary or consequential loss) arising out of or in connection with a ticket holder’s attendance at the Event.
9. Ticket holders are required to conduct themselves in a manner acceptable to NTMEC at all times and otherwise in accordance with the event ticket terms and conditions. NTMEC reserves the right to refuse entry or to remove any ticket holder, including for unacceptable or inappropriate behaviour.
10. Children under the age of 18 are not permitted in the Member’s Bar.
11. All infants and children under the age of 18 are required to be accompanied by an adult at all times and must hold a valid ticket to a Corporate Box.
12. By making a Booking, you acknowledge and agree that NTMEC collects and may use and/or disclose any personal information provided in relation to the Booking (including, without limitation, regarding all ticket holders) in accordance with NTMEC’s Privacy Policy available which can be viewed at - [Northern Territory Major Events Company \(ntmajorevents.com.au\)](https://www.ntmajorevents.com.au)
13. Any and all dietary requirements are to be submitted to NTMEC in writing not later than 21 days prior to the event.

INDEMNITY

14. NTMEC will not be liable for any loss or damage to any item of property brought into a Shared Suite or a Private Suite by a ticket holder. Ticket holders are to ensure that they keep all valuable items in their possession at all times, including (but not limited to) all NTMEC gifts, merchandise, wallets, cameras and mobile phones. NTMEC will not accept responsibility for the loss or, or damage to, any personal items.

DISTRIBUTION OF TICKETS

15. Tickets which have been fully paid for will be sent as an e-ticket to the primary contact noted on the booking form 14 days prior to attending the Event.
16. NTMEC reserves the right in its sole discretion to amend these terms and conditions provided always that it will notify a ticket holder of any such amendment as soon as reasonably practicable.
